



ENVIRONMENTAL POLICY STATEMENT

It is D&D Rail Limited Policy that the company is committed to a continual improvement of its environmental performance. It shall comply with all relevant regulatory and statutory requirements, in particular the Environmental Protection Act 1990.

D&D Rail Limited management undertakes that this Policy will be developed, reviewed and actively supported at Director level and will be consistent with other company policies. The management undertakes that the Environmental Policy will remain relevant to all company activities, products and services, and their environmental effects, and that it will be made, understood, implemented and maintained at all levels within the company.

The aim of the Environmental Policy is to prevent, or reduce, any environmental harm caused by the company's activities through the use of its products, materials, process methods or working practices.

All personnel are encouraged to participate in environmental initiatives and are made aware of:

- The importance of compliance with the Environmental Policy and procedures.
- Their roles and responsibilities within the Environmental Policy and procedures.
- The potential environmental effects of their various work activities.
- The potential consequences of not complying with the agreed procedures.

All personnel are to be made aware of the requirements of good working practice, specifically the following company objectives:

- Reduce waste production
- Reduce energy use
- Prevent Pollution
- Consideration of Noise Emissions
- Observe Improvement Notices
- Observe Discharge Consents and Regulations (atmospheric or waste drainage)
- Control of any associated fumes, waste etc. produced by their actions
- Purchase goods locally wherever possible to minimise transportation

The company maintains an Environmental Purchasing Policy whereby goods purchased are to be environmentally ethically sourced, including the use of FSC or PEFC timber wherever possible.

The company maintains ongoing programmes for the continuous improvement of D&D Rail Limited Environmental processes, including addressing company problem areas. This includes setting and monitoring specific Environmental objectives as part of the Management Review Meeting. The company will implement project specific Waste Management Plans where necessary as part of the project contractual documentation.

Management will monitor the effects of the Environmental Policy by means of "Toolbox Talks"; training and the number of accidents or incidents that are recorded which were potentially dangerous to the environment.

The company will introduce procedures aimed to prevent a re-occurrence of such accidents or incidents.

All our company subcontractors are expected to observe this Policy and operate in an environmentally friendly manner.

The aims of the Environmental Policy will be achieved by the communicating and training of all personnel on environmental matters.

Management undertakes annual reviews of the effects of this Policy and the associated procedures to ensure it is operating correctly and effectively. Any amendments required to enhance operations are undertaken as required.

This policy is to be reviewed annually (as a minimum) unless there are changes in the responsibilities of the persons named within it or other changes of substance, in which case a revised policy will be issued immediately to all existing policy holders.
